Applications will be assessed on the extent to which they meet the following criteria:

- 1. Must be in business for 1 year with business taxes showing \$5k-\$10k revenue
- 2. Must complete the bundle requirements to earn the cash incentive
- 3. Must have CFFCU Business membership with operational checking account
- 4. Either home or business address must fall within a Covid distressed area (ERP Zone by CDFI Fund)
- 5. No non-profits
